Public, Patient and Staff Engagement

I had a very insightful morning accompanying colleagues from our Homeless Mental Health Service to several centres and facilities aimed at providing integrated support to members of the community in the city who may be experiencing homelessness. The importance of connecting people with our services in places where they want to go was very clear.

Working with Partners and Stakeholders

Various LPT Board members participated in a UEC Summit which engaged a range of system partners in working together to understand and address a key system challenge. I also attended an LLR ICB Board Development session covering a range of system topics and supported the recruitment process to appoint a new LLR ICB Chair, although no appointment was subsequently made.

After joining my first People's Council meeting as an observer in March, I had a follow-up meeting with the Chair of LPT's People's Council and LPT's Head of Patient Experience and Involvement. The Council is keen to maintain a link with the NED group through a nominated NED who can periodically attend and engage with its work and members. Arrangements for this are to be finalised.

Chair/NED Appraisals, Recruitment and Succession Planning

NED appraisals have been scheduled and are underway. Ruth Marchington as SID led the approach to the Chair's appraisal collating stakeholder feedback against the new Leadership Competency Framework and engaging with NHSE alongside NHFT's SID. The process is expected to be concluded by the end of May. Thank you to colleagues who contributed.

Following a shortlisting process for the advertised NED and Associate NED opportunities, a Stakeholder Panel and Interviews took place virtually on 19 April. A preferred NED candidate was identified and has been approved for appointment by NHSE, subject to satisfactory employment checks. Onboarding and induction arrangements are in progress. As an Associate NED was not identified a new selection process will be undertaken in due course.
