Trust Board - 24 September 2024 - Chair's Report

Purpose of the report

This is a regular report for information and accountability, summarising Chair and Non-Executive Director (NED) activities and key events relating to the Well-Led framework since the last Board meeting. Activities relating to formal Committees of the Board are reported through custom reports.

Analysis of the Issue

Public, Patient and Staff Engagement

NED Boardwalks and other engagement activities in the period include visits to:

- Beacon Unit
- Facilities Management Team
- Mental Health (MH) Urgent Care Hub
- Nutrition and Dietetics Service, St Lukes Hospital
- East Ward, Hinckley Hospital
- Occupational Therapy Gym, Bradgate Unit
- Arts in MH Service

Equality, Leadership and Culture

Highlights in this period include:

- Attending various network and listening events to support Ethnic and Cultural Minority staff affected by the riots (Chair, Faisal Hussain, Manjit Darby)
- Supporting the Health and Wellbeing Roadshow and some of the welcome events for staff moving to County Hall in which about 150 people participated (Faisal Hussain)
- Opening various events such as the Research Envoy Scheme Celebration event with the CEO and the Learning Disabilities Conference (Chair)
- Attending a workshop on how LPT was progressing against the Workforce Disability Equality Standards (WDES), and next steps (Faisal Hussain).

Working with Partners and Stakeholders

Several NEDs attended the East Midlands Alliance Celebration and Networking event where Boards from across the East Midlands Alliance MH and LP partners came together to hear about the role of the Collaborative, its successes and some next steps including implementation of PCREF.

The Trust's Annual General Meeting received a high level of engagement with over 100 attendees including ICB colleagues and many staff members.

Chair/NED Appraisals, Recruitment and Succession Planning

NED Appraisal summaries will be reported to NHSE at the end of September in line with the required timescale.

Following discussions with both Directors of Corporate Governance, NHSE and NHFT's Council of Governors, NHFT and LPT are currently jointly advertising for an Associate NED. The intention is for the role to support succession planning for NEDs in both Trusts.

Board Development

A workshop on 27 August provided Board members with an opportunity to explore progress against our Lived Experience Leadership Framework with members of the People's Council. There were also updates on our Health Inequalities work and progress with the Learning Disabilities and Autism (LDA) Collaborative, including practical examples and case studies. Several of the Trust's Change Leaders attended the session to engage the Board on progress with our cultural change programme, Our Future Our Way and its various workstreams. Finally, Board members had the opportunity to reflect further on the Well-Led Review recommendations in advance of the outcomes being reported to Public Board.
