Leicester, Leicestershire and Rutland LeDeR 2024 Annual Report

Purpose of the Report

Learning from the Lives and Deaths of people with a Learning Disability and Autistic people (LeDeR) is a national programme that supports health and care organisations to identify opportunities to improve the care they provide, and reduce the inequalities faced by this vulnerable community.

The report is provided to inform the board of the findings from detailed scrutiny of the lives and deaths of local people with a learning disability and/or autistic people by the LeDeR team within the LLR LDA Collaborative.

Through consideration of the report and sponsorship of the recommendations within it the Board may enable local inequalities to be addressed through organisational plans and increased collaboration between partner organisations.
