Board Performance Report - August 2024 (Month 5)

Purpose of the report

To provide the Trust Board with an overview of Trust performance against an agreed set of KPI's for August 2024 (M5 of 2024/25).

Analysis of the issue

Due to the way deadlines have fallen, the Month 5 report has been submitted for presentation to Trust Board without any incorporated feedback from the Accountability Framework Meeting.

Proposal

The following should be noted by the Trust Board when reviewing the report and looking ahead to the next reporting period:

- The Mental Health Core Data Pack dashboard has now been updated to include June-24 data on the FutureNHS site but was not updated in time to be collated into this report. The Core Data Pack Metrics will be updated in the September 2024 Board Performance Report (BPR).
- Readmissions have increased from 7.7% to 12.4%, this is being investigated to ascertain any underlying trends.
- Community Health Services bed occupancy has decreased for a fourth month in a row and has fallen below the 93% threshold for the second month. This will be reviewed for September to understand any underlying issues and / or action required.
- The number of over 52-week waiters for Adult ADHD assessment has increased by 889 patients in
 July 2024 compared to the June 2024. This is following an increase of 793 the previous period and is
 as a result of the resolution of a data discrepancy enabling the alignment of local and organisational
 reports. There is no negative impact on the length of time patients will be waiting for an
 appointment.
