Trust Board - 26 November 2024 - Chair's Report

Purpose of the Report

This is a regular report for information and accountability, summarising Chair and Non-Executive Director (NED) activities and key events relating to the Well-Led framework since the last Board meeting. Activities relating to formal Committees of the Board are reported through custom reports.

Analysis of the issue

Chair/NED Appraisals, Recruitment and Succession Planning

Josie Spencer conducted the Chair's mid-year review, part of which was undertaken with NHFT's Chair Appraisal Panel, including Governors. NED mid-year reviews are scheduled to take place in December.

Stakeholder and interview panels for a Group Associate NED role will be undertaken this month. The panels will include Board members from both Trusts, an NHSE representative and NHFT Governors.

Board Development

A workshop on 22 October 2024 provided Board members with an opportunity to review progress on the Trust's Rapid Safety Improvement Programme, understand the Trust's responsibilities in relation to Medical Associate Professions and hear an update on the Group Strategy development process. Board members also heard about the achievements of the Trust's Raising Health Charity and explored how the Charity could support LPT's strategic priorities in the future. A deep dive on feedback from the Deloitte Well-Led Review took place specifically for NED colleagues, with an opportunity to revisit best practice on good scrutiny/ challenge and Board culture/ behaviours. The day ended with a chance for all Board members to receive their flu and covid vaccinations by our onsite vaccinators.

Working with Partners and Stakeholders

Further opportunities to strengthen our partnership working with the University of Leicester are in train, including an invitation for the Chair to meet with the Dean of Medicine, alongside Executive Directors and our University NED, Liz Anderson, and a workshop with LAHP Board members to explore its future role and development. Manjit Darby is also supporting a learning set for the University of Leicester with an initial focus on the role and responsibilities of the Board. The group will be observing our Public Board in November.

Faisal Hussain is attending a People's Council Development Day in his capacity as the NED link to the Council.
