Report title

Same Sex Accommodation Annual report including annual declaration of compliance.

Purpose of the report

The purpose of this report is to provide the Quality Forum and Trust Board with a summary of the Trust position for the financial year 2023/2024 regarding compliance with NHS England (NHSE) requirements to eliminate Mixed Sex Accommodation (MSA) breaches within all inpatient areas and compliance with national 'Delivering same-sex accommodation' guidance (NHS, 2019).

The report sets out definitions for reporting a breach in line with national reporting requirements.

The Trust has an annual requirement to declare and publish compliance with delivering same sex accommodation; this is included as appendix 1 to this report.

Analysis of the issue

Background

Why is same sex accommodation important?

Every patient has the right to receive high quality care that is safe and effective and respects their privacy and dignity. Providers are expected to have a zero-tolerance approach to mixed-sex accommodation, except where it is in the overall best interest of all patients affected.

A mixed-sex accommodation breach occurs at the point a patient is admitted to mixed-sex accommodation outside the guidance:

- Patients should not normally have to share sleeping accommodation with members of the opposite sex.
- Patients should not have to share toilet or bathroom facilities with members of the opposite sex.
- Patients should not have to walk through an area occupied by patients of the opposite sex to reach toilets or bathrooms; this excludes corridors.
- Women-only day rooms should be provided in mental health inpatient units.

Male and female corridors

Patients may on occasions be admitted into single, en-suite bedrooms in zones occupied by the opposite sex when no bedroom is immediately available in the appropriate area. This will only be facilitated following discussion with the patient and with safeguards in place, including 1:1 nursing care whilst a more appropriate bed is found. These incidents are reported internally as privacy and dignity incidents with detail included and reported as part of the monthly Mixed Sex Accommodation breach report to the Quality Forum.

Reporting

There are times when the need to urgently admit and treat a patient can override the need for complete segregation of sexes with some clinical circumstances where mixing can be justified. These are few, and mainly confined to patients who need highly specialised care, such as that delivered in critical care units or joint admission of couples or family group. An unjustified breach is where mixing occurs that cannot be clinically justified.

In 2023/2024 there was:

- 2 X unjustified mixed sex accommodation breach
- 1 X justified mixed sex accommodation breaches

reported in line with national guidance.

Justified Breach

In May 2023 there was 1 reported **justified** mixed sex accommodation breach within Community Health Services (CHS) Directorate.

A married couple were transferred from LGH who handed over that the two patients should not be separated as it would adversely impact on their distress.

Both patients moved to Ward 4 Coalville into a bay for high visibility and exclusively for them. The third bed in the bay was closed and no admission accepted.

This was in line with the national guidance and definition below.

The joint admission of couples or family groups may be a justifiable breach if it is in the overall best interest of the patient and the patients have expressed a preference for sharing and this consent is recorded.

Unjustified Breach

In June 2023 there was 1 reported **unjustified** mixed sex accommodation breach within Community Health Services Directorate

In support of the system pressure CHS mobilised additional boarding capacity which unfortunately resulted in a single sex breach on Coalville Ward 2 (CV2).

A female patient who was allocated to Dalgleish ward was transferred to CV2, the ward raised the issue of not having a female bed however UHL response was the patient will come and the need for sharing mixed bays

The female patient was moved the following morning to a female area.

In November 2023 there has been 1 **unjustified** bathroom same sex accommodation breach in FYPC/LDA reported on 27th November 2023.

The unit has 3 communal showers, I bathroom and I ensuite facility. Male patients have access to a single sex bathroom and shower in the male zone of the unit and female patients have access to two shower rooms.

From September 2023 female patients had been accessing a shower, with staff escort, in the male zone as one of the shower rooms has been out of use since May 2023 and the ward accepted a 2nd male admission on 18th September 2023.

This ceased on 28 November 2024 as provision was made to temporarily close a bedroom allowing for an additional female shower to be made available.

Decision required

Quality Forum and Trust Board are asked to:

- be assured that internal processes are in place to monitor and report MSA breaches.
- approve the declaration of commitment to deliver single sex accommodation.



Declaration of Compliance – July 2024

Leicestershire Partnership NHS Trust is committed to providing every patient with same sex accommodation as it helps to safeguard their privacy and dignity when they are often at their most vulnerable. The only exception to this is when it is in the patients overall best interests or reflects their personal choice.

Why is same sex accommodation important?

Every patient has the right to receive high quality care that is safe and effective and respects their privacy and dignity. We are committed to ensuring that patients' privacy and dignity is maintained at Leicestershire Partnership Trust. The Trust continues to report all incidents in line with NHS England 'Delivering same-sex accommodation' guidance. The guidance states patients must not:

- Share sleeping accommodation with members of the opposite sex.
- Share toilet or bathroom facilities with members of the opposite sex.
- Walk through an area occupied by patients of the opposite sex to reach toilets or bathrooms; this excludes corridors.
- In addition, women-only day rooms should be provided in mental health inpatient.

Reporting

Compliance of same sex accommodation is monitored and reported internally to the Trust Quality Forum and externally by our commissioners.

In 2023/2024 there were:

- 2 X unjustified mixed sex accommodation breaches
- 1 X justified mixed sex accommodation breach

We will continue to monitor our progress against information that is made available following CQC inspections and staff and patient feedback.
