



Trust Board – 28th January 2025 – Chair's Report

Purpose of the Report

This is a regular report for information and accountability, summarising Chair and Non-Executive Director (NED) activities and key events relating to the Well-Led framework since the last Board meeting. Activities relating to formal Committees of the Board are reported through custom reports.

Analysis of the issue

Chair/NED Appraisals, Recruitment and Succession Planning

All NED Mid-year reviews were completed in December including discussions regarding first terms due to end in 2025. Plans for reappointment/succession will be confirmed following advice from NHSE.

The process for appointing a Group Associate NED has not yet concluded and we are currently working through next steps with NHFT colleagues and Governors.

Board Development

A joint Board Development Workshop was held on 6 December which provided the opportunity for NHFT and LPT Board members to engage with the latest iteration of the Group Strategy and further explore Group governance arrangements including joint Public Board meetings and the role of the Joint Working Group. There was also a helpful discussion to share governance practice on Freedom to Speak Up.

Working with Partners and Stakeholders

Both the Chair and CEO will be engaging in joint planning meetings across LLR and Northants systems to collaborate and align with all partners as much as possible through the NHS planning process for 2025/26.
