## **Chief Executive's Report**

#### **Purpose of the Report**

This paper provides an update on current local issues and national policy developments since the last meeting. The details below are drawn from a variety of sources, including local meetings and information published by NHS England, NHS Providers, the NHS Confederation, and the Care Quality Commission (CQC).

#### Analysis of the Issue

#### **National Developments**

We continue to see increased demand on our healthcare services across the country from a range of viruses including Flu, respiratory syncytial virus (RSV), and norovirus, compounded with cold health alerts issued by UKHSA for the country. Locally, we are working closely with our partners in the system, across health and social care, to ensure our population continue to receive safe and compassionate care during these busier periods. I would like to take the opportunity to thank our staff, volunteers and partners for the additional efforts they are making at a time of extreme pressure.

I would also like to take this opportunity to thank our staff and partners in the County for all their hard work and support to keep our population safe during the recent flooding we have experienced.

#### **COVID-19 and flu vaccinations**

The latest seasonal vaccination data released shows over 28 million Covid & Flu vaccinations have been delivered so far to those eligible. The national booking system closed on 19 December, however patients can still visit COVID-19 walk-in vaccination sites or find a local pharmacy offering the flu vaccine.

The government has accepted Joint Committee on Vaccination and Immunisation (JCVI) advice for the NHS to <u>plan for a seasonal COVID-19 vaccination programme in Spring 2025</u>, the cohorts for the spring 2025 programme will cover:

- adults aged 75 years and over
- residents in a care home for older adults
- individuals aged 6 months and over who are immunosuppressed (as defined in <u>COVID-19</u>: <u>the green book, chapter 14a</u>; Tables 3 and 4)

We will work closely with our ICB to start developing plans for this campaign.

#### Research

The government has announced £100 million of public-private investment to set up 20 new clinical research hubs across the UK to accelerate research into the next generation of treatments. Commercial research delivery centres (CRDCs) across the UK will act as regional hubs for pioneering clinical trials, creating opportunities to test innovative new treatments with the latest equipment and technology. In support of the 10 Year Health Plan, CRDCs will shift clinical trials into community settings, meaning those in under-served regions will be better able to participate in research. This will boost access to new treatments in the trial stage.

These trials will build UK research delivery leadership into all conditions across multi-specialist centres. This includes cancer and obesity, as well as infectious diseases such as flu and respiratory syncytial virus (RSV). The funding is part of a wider £400 million joint public-private investment scheme - the Voluntary Scheme for Branded Medicine Pricing, Access and Growth (VPAG) Investment Programme. It is a unique partnership between the government and the pharmaceutical industry to boost the global competitiveness of the UK life sciences sector and stimulate economic growth

#### Change NHS – 10 year health plan

We continue to contribute to national and regional engagement exercises regarding the 10-Year Health Plan, supporting our population and staff to share their thoughts and feedback through various routes over the coming months ahead of the deadline for final insights/responses on 14 February 2025. #### NHS Trial to boost health and support people in work

An NHS world leading trial will see the creation of 'Health and Growth Accelerators' which will look to boost people's health alongside tackling the conditions that most impact people's ability to work – ranging from cardiovascular problems and diabetes to back pain and mental health issues. Alongside these accelerators, NHS England is working with the Office for National Statistics to assess the economic benefits of several health interventions including talking therapies, bariatric surgery, treatment for endometriosis, and the NHS Type 2 Diabetes Prevention Programme.

The trial will cover South Yorkshire, North East and North Cumbria, and West Yorkshire – parts of the country most affected by economic inactivity driven by ill health.

The analysis will also cover the impact on waiting times, employment rates and earnings while feeding into work by the Office for Budget Responsibility and the government on labour market effects.

In line with the broader priority of shifting from treating sickness to prevention, the accelerators will work on preventing diseases that lead to people dropping out of work including diabetes, heart



attacks and strokes. This could include more support for people to manage their blood pressure or diabetes, more action to find people at risk and supporting people to make lifestyle changes.

The accelerators will also test the use of digital tools to support mental health therapy sessions and musculoskeletal pain as well as potentially placing employment advisors into clinical pathways and in GP settings.

If the trials are successful in boosting health and impacting local employment, they could be rolled out by the NHS on a wider scale.

#### **CQC - Regulators ' Pioneer Fund project**

In February 2024 the CQC announced they would be working with National Voices and Point of Care Foundation on a Regulators' Pioneer Fund project to develop a voluntary improvement framework for integrated care systems (ICSs) to understand how well their engagement with people and communities is helping tackle health inequalities.

The testing phase took place through Autumn 24 with four ICSs; Black Country ICS, Gloucestershire ICS, Hampshire and Isle of Wight ICS and Nottingham and Nottinghamshire ICS. The testing phase has now been completed and highlighted key opportunities such as;

- **Flexibility:** ICSs appreciated the framework's adaptable structure, allowing them to focus on areas most relevant to their unique contexts.
- **Guidance:** ICSs highlighted the need for clear guidance and examples to support implementation.
- **Impact Measurement:** Feedback emphasised the importance of ensuring the framework helps ICSs measure the tangible outcomes of their engagement efforts on reducing health inequalities.
- **Resourcing:** Integrating the framework with existing strategies for population health to support managing resource limitations while still tracking impact.



The health inequalities improvement framework will launch as part of a dedicated virtual event in February, set to bring together ICS leaders, stakeholders, and partners to explore the framework's practical application and its role in tackling health inequalities.

#### First ever men's health strategy

The Health and Social Care Secretary has recently announced plans for a men's health strategy to be published in 2025. The strategy will consider how to prevent and tackle the biggest health problems affecting men of all ages, which could include cardiovascular disease, prostate cancer and testicular cancer, as well as mental health and suicide prevention and will form a key part of the government's 10 Year Health Plan. A call for evidence on the strategy will seek views on what is working and what more needs to be done to close the life expectancy gap between men and women.

#### **Refreshed plan for NHS Workforce**

To support the 10 Year Health Plan, expected in Spring 2025, the government and NHS will unveil a refreshed workforce plan in Summer 2025 that aligns to the three key messages of the 10 year plan – moving activity from hospital to the community, analogue to digital, and sickness to prevention.

#### **NHS** manager proposals

A public consultation was launched on 26 November 2024 seeking views on government proposals to regulate health service managers, ensuring they follow professional standards. The consultation will run for 12 weeks, at which time the responses will be considered and next steps set out.

Patients, health and care staff, and professional bodies are also being asked for their views on whether to introduce a statutory duty of candour which would make NHS managers legally accountable for responding to concerns about patient safety. We have also been invited to share our feedback through the consultation.

#### Innovation for Healthcare Inequalities Programme: Impact and learning report

The Innovation for Healthcare Inequalities Programme: Impact and learning report was published on 6 December. The NHS England's InHIP programme is a collaboration between the Accelerated Access Collaborative (AAC), NHS England's National Healthcare Inequalities Improvement Programme and the Health Innovation Network, delivered in partnership with integrated care systems (ICSs).

It aims to address local healthcare inequalities experienced by deprived and other under-served populations.

Project teams (comprising of clinical and non-clinical expertise) from across the country are working together with their local communities to identify, address and minimise healthcare inequalities through projects to improve access to the latest health technologies and medicines.

These technologies and medicines are focused on five clinical areas of priority that closely align with the national <u>Core20PLUS5</u> approach to reducing healthcare inequalities, which includes maternity, mental health, respiratory, cancer diagnosis and cardiovascular disease.

As highlighted in the report, over 34,000 people from underserved groups or deprived areas have benefitted from InHIP Wave 1 interventions, with around 8,000 patients gaining access to an innovative product on a treatment pathway.

Over 1,200 project sites were able to deliver a new pathway and / or innovation to patients. Almost 4,000 patients had broader health needs identified that resulted in them being referred on to additional services beyond the original core project focus.

We shall be reflecting on the recommendations within this report to inform our own local efforts to tackle health inequalities.

#### **Local Developments**

#### National Staff Survey 2024

More colleagues than ever from our LPT family took the time to use their voice and contribute to this year's National Staff Survey.

The Trust response rate of 58.4% was a 4% increase from last year, equating to just under 4000 colleagues, making it our highest response rate in the last five years. Feedback brought together diverse voices from all areas across our Trust.

We also had a record number of valued bank staff complete the survey (35% compared to 30% last year).



The national results are due to be published in March 2025, and as always will use this to inform areas of focus to continue to build a great place to work and receive care.

#### The Bigger Picture – developing our strategy for 2025 and beyond:

Our work towards a new Group strategy representing both Leicestershire Partnership Trust and Northamptonshire Healthcare NHS Foundation Trust continues with a second period of engagement. At this stage, a draft mission, vision and core themes have been returned for further thoughts from staff, service users and stakeholders to develop a group strategy for our two separate but connected organisations – thank you to everyone who contributed their thoughts.

#### Face masks in community hospital wards

We are asking all visitors to our community hospitals (and the CHS wards in the Evington Centre in Leicester) to wear a mask in clinical areas with immediate effect. This is due to an increase in the number of patients with respiratory conditions, including flu and RSV. However, mask wearing is NOT currently a requirement in our mental health wards.

Mask wearing is also a requirement at wards operated by University Hospitals of Leicester. We continue to keep the situation under constant review.

#### LPT Art Exhibition – The Bradgate Mental Heal

We are pleased to have launched the 'Inspire' exhibition as a permanent display in a corridor at The Bradgate Mental Health Unit, which is open to all service user in-patients, visitors, and staff. Funded by the Arts Council we worked with in-patient and out-patient mental health service users at the ArtsCafe Group at The Bradgate Mental Health Unit and at the ArtSpace Group at The Attenborough Arts Centre in Leicester.

The initial community-based part of the project involved an open call out for community models to be body painted live at Inspire events. The designs for the models were based on interviews with them on what inspiration, health, wellbeing, and community meant to them, resulting in a collection of visual interpretations personal to the models. The same design model was used for our service users who created some of the work on display in this exhibition, alongside work from the community.



#### New ward repens at St Luke's Hospital

A brighter, better, ward has reopened at St Luke's Hospital. Ward 3 admitted its first patients on Monday (09 December 2024) after a three-month closure to replace its roof, and install new fire doors which meet current safety standards.

Contractors also took the opportunity to "box in" pipework in the patient areas, install dementiafriendly markings, and give the place a thorough redecoration. The 14-bed ward provides care for sub-acute patients, including many who need an intermediate stay between treatment at Leicester's acute hospitals and a return home. St Luke's other inpatient ward provides care for those who have experienced a stroke.

The work was carried out by NHS Property Services, which owns the building, investing approximately £575,000 in essential upgrades at St Luke's Hospital as a part of our commitment to deliver excellent patient care.

#### Winter wellness campaign to support our local population

With coughs, colds and tummy bugs in infants and children on the rise at this time of the year, Leicestershire Partnership NHS Trust, the Leicester, Leicestershire and Rutland Integrated Care Board (LLR ICB) and Leicester Hospitals have teamed up to create new online winter wellness hubs on the Health For Under 5s and Health for Kids websites. The hubs have lots of articles and advice on how to avoid getting ill and when and where to go for help if kids do become unwell. What's more, all the content has been put together by trusted NHS health professionals, including doctors and nurses and contains advice on how to find local support.

The online hubs support parents and carers to easily find the advice they need and feel confident about when to seek further medical help if it's needed, especially as it can also be a really busy time of year in GP practices and hospitals. The information is also being distributed as leaflets to parents through our Healthy Together teams through their community visits.

#### Truck stop event offers mental health support

Lorry drivers and road users had an opportunity to speak to health and wellbeing professionals at Junction 23 M1 Lorry Park in December. The jointly hosted event by LPT's Charnwood CMHT adult team and Leicestershire County Council's Public Health team, Local Area Coordinators (LACs) took place just off the M1 in Shepshed, and followed a previously successful event earlier in 2024.

The truck stop event gave lorry drivers the chance to find out more information about mental health and wellbeing, with each person receiving a goodie bag with a variety of information about services and tips to look after their health and wellbeing.

The initiative is also an ideal chance to target a predominantly male demographic, with mental health charity MIND indicating that 30% of illnesses in the transport and logistics industry are related to mental health, though this figure may be even higher.

Over 95% of the lorry driving industry is male, and men are less likely to address mental health concerns, leading to a higher suicide rate.
