# **Chair's Report**

## **Purpose of the Report**

This is a regular report for information and accountability, summarising Chair and Non-Executive Director (NED) activities and key events relating to the Well-Led framework for the period (February/March). Activities relating to formal Committees of the Board are reported through custom reports.

## **Analysis of the issue**

### Chair/NED Appraisals, Recruitment and Succession Planning

Arrangements for NED reappointments are in progress with NHSE. However following Alexander Carpenter's decision not to extend his tenure after 31 May 2025, the potential for an NHFT NED to be considered for appointment is being explored. In the meantime, we are grateful to Alexander for his continued engagement and commitment to the Board and LPT.

The process for appointing a Group Associate NED did not conclude with an appointment. We are re-assessing the approach and considering whether an Associate NED placed in one organisation initially, with the option to develop across both LPT and NHFT, might be more successful.

We are beginning to plan for NED appraisals which will take place across the coming months noting that information about any new national requirements for Chairs and NEDs is still awaited.

Congratulations are extended to to Faisal Hussain, Deputy Chair, who has been selected for NHSE's Aspirant Chair Talent Programme following a rigorous process including a panel interview involving established Chairs. The programme is targeted at candidates who are expected to be ready for appointment within 12-18 months.

#### **Board Development**

A joint Board Development Workshop was held on 25<sup>th</sup> February which provided the opportunity for NHFT and LPT Board members to engage with the latest iteration of the Group Strategy, to discuss the Group's priorities for 2025/26, receive an update on progress with University status, explore the Insightful Provider Board guidance and partake in a workshop around Digital value and strategy. The Boards also reviewed proposals for joint Board meetings in Public for 2025/26.

#### **Working with Partners and Stakeholders**

The Chair and CEO are engaging in planning meetings across both systems, LLR and Northants, to collaborate and align with all partners as much as possible through the NHS planning process for 2025/26.
